2021/91 Public Participation

Among items raised this evening included:

Public Transport: buses are still leaving their engines running at the timing point in Station Road; the already appalling 156 service is being reduced to one every two hours from the hourly service and trains are still running at a reduced one per hour from two per hour and these are subject to regular cancellation – there was also a query re why the 156 follows such a long route to get to St Helens Town Centre. Cllr Pearson said all issues will be raised formally in writing to LCR Transport Committee The reduction in train service had already been raised by Cllr Pearson with the LCRTC and a response is awaited. Residents commented that where public transport would be used, people are now using cars due to the lack of bus and train services. Cllr Pearson commented that £710M had been granted to Liverpool City Region for transport and a significant amount of this should be investing in services for St Helens. He further commented that an H&S assessment on the rail station carried out by Cllr Dennis McDonnell had been forwarded to LCR Transport Committee and that Cllr Liam Robinson, the Chairman of this committee will be attending the December meeting of the Parish Council.

Rail bridge at Spindle Hillock – query re when it will be completed (from 2015). In answer to a query re the lift that had first been raised many years ago, Cllr Pearson confirmed this had been raised again more recently and the response was that funding is not available but it is an issue that both Parish and Ward councillors continue to pursue.

<u>Library</u>: it was reported that there are no decisions yet on any of the St Helens library. A young resident spoke briefly about our library being the only place to read and study locally and given the dreadful transport links, she felt it was important to retain this service so local students are not disadvantage by lack of available facilities. This comment was met with a round of applause,. The importance also to older people was also mentioned along with the social side of the library. A wish to retain not only the service but the building was also noted.

<u>Pathways</u>: the narrow state of existing pathways was commented on an there was a request for consideration of a track/path around the perimeter of Birch Grove Playing Fields to support health and wellbeing in the area.

Litter Bins: is was requested for the bins in the play area adjacent to the Community Hall to

be relocated outside of the area.

<u>Community Noticeboard:</u> there was a request for relocation of the St Helens Council noticeboard from the grounds of Garswood Primary School to outside the shops on Hamilton Road to facilitate ease of access to information by residents. Cllr Pearson commented the land on Hamilton Road doesn't belong to St Helens Council which is the reason it was originally located in the school grounds but will investigate.

<u>Speeding</u>: Booths Brow and Leyland Green Road were specific roads commented on and confirmation that nothing had yet been done to encourage traffic calming.

<u>Downall Green Signage</u>: a query on progress with this: Cllr Ainsworth-Barton confirmed it had been ordered and ward councillors will chase for an installation date.

Several thanks were offered by residents present to FOSG and other volunteers for clearing and tidying the Remembrance area at Holy Trinity Church; to all those who have decorated Downall Green and Garswood for Remembrance with particular mention to Jason Shawcross plus Knit an Natter group – a round of applause was given.
